I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Hashemite Kingdom of Jordan for the Promotion and Protection of Investments signed in Amman on 10 October 1979(¹), and in accordance with the provisions of Article 9, to propose that the Agreement shall be extended to Hong Kong.

If this proposal is acceptable to the Government of the Hashemite Kingdom of Jordan, I have the honour to suggest that the present Note and Your Excellency's reply to that effect shall constitute an Agreement between the two Governments which shall enter into force on the date of your reply.
