I have the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and Government of the Republic of Singapore for the Promotion and Protection of Investments signed at Singapore on 22 July 1975⁽¹⁾ and, in accordance with the provisions of Article 11, to propose that the Agreement shall extent to the Bailiwicks of Guernsey and Jersey, and the Isle of Man.

If this proposal is acceptable to the Government of the Republic of Singapore, I have the honour to suggest that the present Note and You Excellency's reply to that effect shall constitute an Agreement between the two Governments which shall enter into force on the date of You Excellency's reply.
