The Embassy of the United Kingdom of Great Britain and Northern Ireland in Zagreb presents its compliments to the Ministry of Foreign and European Affairs of the Republic of Croatia and has the honour to refer to the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Croatia for the Promotion and Protection of Investments, done at London on 11 March 1997 (hereinafter referred to as “the Agreement”).

The Embassy has the honour to propose on behalf of the Government of the United Kingdom of Great Britain and Northern Ireland the conclusion of the following agreement:

Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Croatia on the Termination of the Agreement between the Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Croatia for the Promotion and Protection of Investments, done at London on 11 March 1997 (hereinafter referred to as the “Termination Agreement”).

1. The Government of the United Kingdom of Great Britain and Northern Ireland and the Government of the Republic of Croatia (hereinafter referred to as “the Parties”) agree to expressly terminate the Agreement in accordance with the provisions set out in this Termination Agreement.

2. The Parties agree that Article 14 of the Agreement shall not produce any legal effects after the entry into force of the Termination Agreement.

If the aforementioned proposal is acceptable to the Government of the Republic of Croatia, the Embassy has further the honour to propose that this Note together with the Ministry's Note in reply shall constitute the Termination Agreement.

Each Party shall notify the other in writing, through diplomatic channels, of the completion of the procedures required by its law for the entry into force of the Termination Agreement. The Termination Agreement shall enter into force on the date of the receipt of the later notification by which the Parties have notified each other that they have completed their respective legal procedures.

The Embassy of the United Kingdom of Great Britain and Northern Ireland in Zagreb avails itself of this opportunity to renew to the Ministry of Foreign and European Affairs of the Republic of Croatia the assurances of its highest consideration.
